It was agreed that a response would be sent to the planning authority suggesting a condition should be applied relating to the use of low-level lighting. Concern was also raised whether the application does comply with the farm diversification planning policy.

72/2023	Highways An emergency road closure had been put in place by Cumberland Council due to the likelihood of danger as a result of an embankment collapse threatening the carriageway.

The Chairman provided an update from Cumberland Council regarding the closure of Bell Lonning which stated:

"We inspected the highway and discovered a significant amount of material had been lost from the embankment along the short length that you describe, including the timber post and rail fence that was installed post Desmond Flood.

During the inspection we instigated the closure as it is unsafe.

Our current plan to resolve the issue and remove the closure at Bell Lonning is as follows:

- 1. Carry out a dive inspection of the full length of Bell Lonning to determine any unknown additional requirements for bank strengthening.
- 2. Install temporary bank protection along area of significant erosion to prevent further loss.
- 3. Carry out topographical survey of new profile of lost embankment.
- 4. Finalise options report for the repair of the section of lost embankment.
- 5. Engage with EA, NE & other interested parties with the proposed solution identified in the options report to get outline acceptance of proposal.
- 6. Carry out detailed design of solution following outline acceptance of the solution (this also includes any necessary environmental/ecological surveys being carried out).
- 7. Procure contractor to carry out embankment works.
- 8. Contractor commences works on site (the contractor attains required consents for the works prior to works commencing).

Items 1 and 2 will be carried out as soon as water levels allow divers to enter the watercourse but will also be dependent on the availability of our 3rd party diving contractors. It may be necessary that the divers carry out inspections on higher priority infrastructure before carrying out the inspection along Bell Lonning.

We have identified funding to allow the construction works to be carried out during this summers (2024) in-river working period. However, liaison with 3rd parties and the complexity of the solution could potentially delay the works until the in-river working period of 2025.

Due to the scale of loss of material at the short section of embankment, Bell Lonning will be closed to all vehicular through traffic until the permanent solution can be installed."

The Chairman reported that a further update had been received advising that Cumberland Council are drawing up a plan ahead of the normal timeline and will be moving ahead as quickly as possible. Cllr Johnson agreed to request a programme of works from Cumberland Council.

The following matters were reported:

Pot holes/road surfacing breaking up on the B5299 from Goose Green towards Welton and from Welton towards Nether Welton.

Pot hole before the turn for Grassgarth.

Fly tipping near the crossroads at Goose Green.
